Jane Doe, Goodin County State's Attorney, informs the Court that **JOHN M SMITH** committed the following offense(s) within Goodin County Illinois, on or about January 23, 2009, to wit:

**COUNT I**  
UNLAWFUL POSSESSION OF WEAPONS BY FELONS in that said Defendant a person who has been convicted of a felony under the law of Illinois, knowingly possessed a 25 mm handgun prohibited under Section 24-1 of this Act or any firearm or any firearm ammunition in violation of **SECTION 24-1.1(a) of ACT 5 of CHAPTER 720 of the Illinois Compiled Statutes** of said State. Class 3 Felony

**COUNT II**  
RECKLESS DISCHARGE OF A FIREARM in that said Defendant endangered the bodily safety of Sam Smith in that, while acting in a reckless manner, he discharged a firearm and in so doing the defendant endangered the bodily safety of the victim by shooting the victim in the leg in violation of **SECTION 24-1.5(a) of ACT 5 of CHAPTER 720 of the Illinois Compiled Statutes** of said State.
