Paid Subscriptions

As a public service, **JUDICIUM** provides you free access to most of the court's publicly-available data on any single case. Paid subscriptions, on the other hand, add sophisticated time-saving services which package court data in various useful ways, and can let you **see** some **non-public data** automatically, e.g.,

- **See Court Reporter initials** on case minutes to facilitate transcript requests
- **See Document Control Number** – of interest to Probation and Law Enforcement Officers

Subscriptions in courts with the **EXTENDED ACCESS SERVICE** can also let you **see other non-public data**, such as **juvenile cases and addresses**, with the court's permission: By default, judge or probation officer subscribers can see the same information that the public can see. If the court chooses to participate in the **EXTENDED ACCESS SERVICE**, it can set up distinct "Security Groups" with the right to see specific non-public data.

Subscription Services which cover Multiple Courts



Individualized views of data for one or more participants, including attorneys, judges and law enforcement officials – for all cases which the court associates with the participant, across all participating counties

- **See docket information** the way **Attorneys** need to see it.
- **See your schedule** for days in court for **all** our participating counties
- **See your case list** for a given day, in-depth hour-by-hour, with easy access to case specifics
- **See judges' case schedules**
- **See opposing counsel's case list**
- **See current & past cases** for judges and counsel, with the ability to review case specifics
- **ICal** – use the **"get"** link to **download** a hearing **into your calendaring system**, e.g., Microsoft Outlook
- View current & past case info when reviewing **potential clients**, including dispositions, histories, payments, fines & fees
